OR who have passed Plus Two or equivalent examination recognized by MG University with other subjects under part III optionals provided they have secured 45% of the aggregate.

## Merit Marks shall be Arrived at as Follows

B.Com. Computer Application (Vocational Model II)	Marks obtained in Part III Optimal at +2/ equivalent exam less handicap marks plus a weightage of 50 marks in each of three subjects of Commerce combination subject to a maximum of 150 marks plus bonus marks if any. The optionals concerned under part III will be Commerce, Commercial Correspondence and Commercial Geography, Accountancy, Book Keeping and Accountancy, Economics, Life Insurance and Salesmanship, Banking with Secretarial Practice, Business studies, Mathematics, Computer Science / Computer Application, Informatics Practice, Management, Informatics Practice & Management.
B.Com. Finance & Taxation (Vocational Model II)	
B.B.A.	Marks obtained in Part III of +2/equivalent less handicap marks with 50% quota for Arts & Commerce groups and 50% quota for science group - plus weightage marks if any.
B.C.A.	Marks obtained in part III less handicap marks plus marks obtained for Mathematics / Computer Science (Best of Two) plus bonus marks if any.
M.Com. (Finance & Taxation)	CCPA secured for Part III core courses is converted in to percentage marks by multiplying the same by 10. The percentage of marks thus obtained is converted in to marks out of 1000 by multiplying the same by 10.

## Anti-Ragging Warning

Ragging of any type or dimension is banned on college campus. The college will not tolerate any student indulging in ragging and direct or indirect harassment of fellow students on the campus or outside it. Following the ruling of the Supreme Court of India, admission may be refused to an applicant if it was discovered that he/she had indulged in ragging in the past. Admission to a student may also be cancelled and he/she may be rusticated from the institution if his or her indulgence in ragging was noticed after joining the College.

## As per UGC vide its letter no. F.1.16/2007 (CPC-II) dated June 17, 2009, punishment for participation in/or Abetment of Ragging:

1. Cancellation of admission.
2. Suspension from attending classes.
3. Withholding/withdrawing scholarship/fellowship and other benefits.
4. Debarring from appearing in any test/examination or other evaluation process.
5. Withholding results.
6. Debarring from representing the institution in any national or international meet, tournament, youth festival, etc.
7. Suspension/expulsion from the hostel.
8. Rustication from the institution for periods varying from 1 to 4 semesters or equivalent period.
9. Expulsion from the institution and consequent debarring from admission to any other institution.
10. Fine up to Rs. 25,000/-

## Affidavit by students and parents

Each student and his/her parents/guardian shall have to furnish an affidavit along with the application form to the effect that they will not participate in or abet the act of ragging and that, if found guilty, shall be liable for punishment under the penal law of India.

Students are strictly prohibited from Campus Politics and the use of tobacco products, drugs, alcohol, chewing gum etc. They should not bring or use Mobile phones in the campus.

Students shall wear the prescribed uniform dress and ID card on all regular working days in the most modest manner.

## Admission

50% of the seats including seats reserved for SC/ST and SEBC (Socially and Educationally Backward Classes) shall be through CAP (Centralized Allotment Process)

- Selection and admission will be made in accordance with the rules laid down by the Govt. and University.
- The selected candidates will have to attend the interview along with parents / guardian.
- At the time of interview the applicant should produce the Allotment Card / Interview Card and the following documents in original.
  - a) Transfer Certificate
  - b) Conduct Certificate
  - c) Qualifying Certificate or Statement of Marks
  - d) SSLC Book
  - e) Community Certificate in the case of SC/ST, SEBC & OBC
  - f) Four copies of recent passport size photograph with name & programmes on the reverse.
- On securing admission the pass certificate of the qualifying examination and other certificates are to be surrendered at the college. The students are therefore advised to keep with them attested copies of their SSLC Book and other certificates for their interim use. The certificates shall be returned to them only at the end of the programme.

Conveyance will be provided to the students from Aniyilappu, Erattupetta, Thidanadu, Kaduvamuzhy etc. It will be mandatory for all the Lady students to avail the college bus facility.
